Mississippi Section Report for February 2022

From SEC KC5IMN: For 2021, MS ARES SET was based on a severe cold outbreak across the south-central US; we called it Snow-ma-geddon. All modes of severe weather were realized during this 12-hour test with widespread infrastructure disruptions, stranded motorists, warming center establishment, National Guard emergency supply air drops, listening for maritime distress signals and stranded motorists calling for help on citizens' band radio. Mississippi's strength with EMCOMM is our NVIS HF capabilities which are based on one of the state's glaring amateur radio weaknesses; there's not a lot of VHF/UHF ham radio infrastructure in the state. HF NVIS point to point voice and digital comms are the norm day-to-day. The key to the SET for MS ARES is to keep it interesting enough to get operators to participate.

For 2022, we'll be preparing for a major CYBER event impacting infrastructure and SCADA systems across the state. Our goal is to deploy multiple operators in multiple counties and in the larger metro areas to work point to point VHF-UHF with temporary repeaters and utilizing our established HF NVIS processes. The tentative date for the SET is Aug 6, 2022. More to follow on the preparation and training to support this important event.

Robert notes that the 2021 SET Results have been submitted to ARRL Headquarters. They are anticipated to be published in the July QST.

The 19th Mississippi QSO Party is straight ahead on April 2 and 3. Hams from all over will looking for just one Mississippi QSO to complete their Worked all States, or find a rare Mississippi County, or maybe just get a certificate for winning their state in the QSO Party. Project Chairman KG5YEE reports that on March 5 the Vicksburg Amateur Radio Club assisted with the 43rd annual Run Thru History 10K run and 5K walk. The race was held entirely in the Vicksburg National Military Park winding through rolling hills covered in monuments and memorials. Radio operators were stationed at each mile marker as well as the start/finish line to relay race information to the race coordinator and call out times to those runners that needed it. Those assigned to mile markers were: KI5IRT, W5WAF, K5IMT, N5JGK, K5VXV, W5SFL, KC5VTN, N5KWT, KG5OVR, and KG5YEE. KD5DHR and KC5QCN participated as a runner or walker and carried a radio. As a note of interest, KC5QCN has participated in every one of the 43 race events. Wow!!
