From KB5SZJ in Lauderdale County: We are working on a new NVIS antenna for the EOC. The current system sustained damage from some other work done outside the building. The new antenna should be operational before Field Day and will be tested then. Also, we have been working on building up membership by working with Hams in both Clarke and Newton counties. We now have two in Clarke that are very active as well as three in Newton. The two in Clarke have already taken Skywarn classes and are very motivated. We are hoping to have a test session scheduled by August if all goes well and have an antenna class getting ready to start up.

From Hinds County EC KG5SQZ: Central MS ARES completed testing and evaluating the Hamshack Hotline. We see it as a means of quickly connecting members of the leadership team individually or as a group by using the conference bridge. The VM blast feature allows an individual to leave a voice mail message for all connected members by dialing a single number. Although the system is internet based and is subject to its vulnerabilities it is another tool we can use during normal times. Perhaps in the future other members will decide to join Hamshack Hotline.

From Marion County EC AF5NG: I presented an overview of ARES, Goals, Mission, and Served Agency support to the Marion County Emergency Preparedness Committee. Marion County was well represented with Marion County Emergency Management, Power Companies, Water and City Maintenance, Fire Departments, Sheriff and Police Departments, City and County Officials in attendance. There were many questions and several attendees expressed interest in getting their Amateur Radio License. Further, ARES has been extensively practicing simplex operations to prepare for a "repeater down" scenario. The interest in these drills has been surprisingly high and has reinvigorated the interest in ARES operations.
