The 22 nd MSQP is now history. There is good news and bad news. At of the start of the QSO Party 55 Mississippi Hams had signed up in 43 counties to put on the QSO Party and most showed up. Mississippi was well represented.

On the Bad News side, the much hoped for good 10- and 15-meter conditions for stateside QSO Parties never happened. The skip was long for most of the day. Good for DXing but not QSO Parties. 20 was so-so. 40 was about the same until about 6 PM, but then it was gang busters for the next 3 hours. 80 and 3862 never really got going.

The fun is over. Now the hardwork begins ...checking logs. More to come.

Following a fun long weekend of the MSQP and the eclipse, Mother Nature sent a major storm along the Gulf Coast. Pearl River County EC AB6Z reports that the PEARL LEAGUE (Pearl River Emergency Amateur Radio League) was activated as the storm approached. During the storm event they were able to send multiple emergency messages to the EOC in Poplarville and also to adjacent counties and parishes including warning Hams in the Kiln area that tornados were heading in their direction before the National Weather Service was able to regain connectivity in order to issue a warning. PEARL ran on generators as they had no power until mid - afternoon. All communications equipment ran perfectly throughout the event.

KG5SQZ reports that 15 members of CMSARES, under the direction of KJ5ET, supported the Breaking the Loop Foot Race at the Barnett Reservoir. Race officials and runners appreciated them being there and said they felt safer seeing the team on site being identified by their Emergency Communications vests. The team received a hearty round of cheers and applause when officials announced Ham Radio communications support for the event. ARES is grateful to KI5TOL, who helped a station with radio problems throughout the event, even though he was not signed up. Special thanks to KZ5HAT, who was assigned as Relay Station between NCS and Race Control.

ARRL Membership in Mississippi was 955 as of April 1 down 21 from last month. The dues increase is really starting to take hold. Unfortunately, this will probably go on for a year. ARRL Headquarters indicates that a 6% to 8% drop in membership usually happens with a dues increase. This means probably down to from 920 to 940 for Mississippi. Mississippi Ham Radio is not "going to hell in a handbasket" with 22 new Hams in March and 10 upgrades, however, ARRL membership is in for some rough sledding. On the other hand, the ARRL can't keep on having a million-dollar budget short fall year after year. Tough situation.
