Mississippi Section Report for May 2024

The 21st MSQP is now history. The 249 logs submitted have been checked. 79 Mississippi Stations were on the air in 38 of Mississippi's 82 counties. Here are the results:

Interest in FT4/FT8/RTTY continues to increase. Of the 42 Mississippi logs submitted 19 stations operated some digital and 7 of these were digital only.
